Application in the prescribed PRINTED Application FORM which will be ready at the eleven district SP offices/Police Reserve are invited from candidates both male and female who are permanent residents of Meghalaya to fill up expected 33 vacancies in the Armed Branch Sub-Inspector of Police (ABSI) for the **Special Forces-10 (SF-10)** in the scale of pay of Rs. 14100-350-16550-EB-460-620-27510 P.M. as admissible under the Rules from time to time plus other allowances and other special allowances as follows:

**CANDIDATES WHOSE APPLICATION FORMS ARE REJECTED WILL HAVE TO SIGN IN THE APPLICATION FORM REJECTION REGISTER AND THEIR APPLICATION FORMS WILL BE KEPT BY THE PRINCIPAL, PTS AND BY EACH DISTRICT SP OF THE ELEVEN DISTRICTS.**

III. **The printed duly filled in application form should be submitted along with attested copies of the following:**

1. 4 (four) recent passport size photographs.
2. S.T./ S.C. Certificate – for S.T./ S.C. candidates of Meghalaya.
3. Age certificate as per HSLC/SSLC Certificates/Admit Cards or their equivalent certificate testifying the date of birth/age.
4. Educational Qualification certificates.
5. Additional qualification, if any.

Please note (Domicile/Residence certificates will be required in doubtful cases at the time of issue of admit cards/or appointment). The processing fee for each form shall be Rs 50 by cash which should be paid to the application receiving centre of each District SP and the Principal PTS and a receipt is given to the candidate.

#### IV. ELIGIBILITY

##### A. Age :

A candidate should not be less than 21 years and not more than 27 years as on 01.01.2016 with usual relaxation of 5 (five) years in case of candidates belonging to the SC/ST.

##### B. Education Qualification

Graduate in any stream from a recognized University.

Provided that the serving police personnel, who have bachelor's degree, will be given age relaxation of five (5) years and will be permitted to appear in the selection test for the post of ABSI.

**A candidate suffering from any of the following physical deformities will be rejected.**

1. Knock Knee
2. Bad eyesight
3. Colour Blindness
4. Flat Foot
5. Night Blindness
6. Defective alignment of eyes.

V. **TESTS:**

Candidates **should bring** the following documents with them at the time of **appearing for the tests as well as during interview.**

1. Original SC/ST Certificates- for SC/ ST candidates.
2. Original HSLC/ SSLC Certificates/Admit Card, or their equivalent, testifying the date of birth.
3. Original Educational Qualification Certificates/ Additional qualifications Certificates.
4. Pen, clip board, short pant, canvas shoes etc.
5. Domicile/resident certificates if asked by the board at the time of issue of admit card.

A. **PRELIMINARY MEDICAL TESTS: -**

On the day of recruitment, candidates will be subjected to preliminary medical tests before they go for physical tests/written tests.

The scheme of recruitment tests to the post of ABSI and the maximum marks assigned for each event shall be as follows:

(i)	Physical Efficiency Test	-	250 Marks
(ii)	Written Examination	-	150 Marks
(iii)	Interview	-	<u>50 Marks</u>
	Total maximum marks	-	450 Marks

The Central Selection Board shall decide the number of candidates to be called for interview based on the total number of vacancies.

**GENERAL INSTRUCTIONS**

- (1) Candidates shall have to appear for Physical Tests, Written Examination and Interview on the date and place indicated in the Photo Admit Card at their own expenses.
- (2) Only one Photo Admit Card will be issued against one application accepted after scrutiny.
- (3) The following information in the Application Form must be **given in full and in Block letters.** Abbreviations not allowed
  - a. NAME
  - b. PARENT'S NAME
  - c. ADDRESS (Including District, P.O. , P.S and Pin Code No.).

- (4) Detailed and correct postal address should be clearly mentioned in the application form for prompt administrative action by the department.
- (5) After preliminary screening of the application forms, eligible candidates will be issued call letters with admit cards by the Secretary of the Recruitment Board.
- (6) Any correspondence or queries in connection with this advertisement should be made only to the Secretary of the Central Selection Board, i.e. Principal, PTS.
- (7) Provisional appointment will be given in order of merit as per Government Reservation Policy on recruitment, subject to Medical fitness and satisfactory verification of character and antecedents.
