**DETAIL ADVERTISEMENT FOR ENGAGEMENT OF CONSULTANT.**

For Implementation of Renewable Energy programme, MNREDA invites application on Standard Form from eligible candidates who are citizens of India for engagement as CONSULTANT on consolidated salary of Rs.50,000/- (P.M.) for a period of 12(twelve) months, which may be renewed depending on sanction. The details are as follows:-

- a. The MNREDA will hire/employ Consultants to handle the following tasks:-
  - i) To develop various Renewable Energy Projects based on the provisions of different programmes of the Ministry of New and Renewable Energy, Govt.of India including programmes by MNREDA .
  - ii) To conduct in-depth survey and resource mapping of targeted areas and develop project proposals as also supervise their implementation.
  - iii) To undertake periodic monitoring of the implemented projects and suggest means to rectify the shortcoming of the projects, if any.
  - iv) To assist MNREDA in any work awarded by the Ministry
  - v) To work on evacuation of generated power from renewable projects to main grid
  - vi) To assist MNREDA to achieve Renewable Power target
  - vii) To assist in implementation of Solar PV Pump projects for farmers
- b. The minimum qualification and experience of the each Consultant to be engaged are
  - i) Engineering graduate preferably with Civil, Mechanical, Electrical and Electronics and RE/Energy Studies Branch with RE background or M.Sc. preferably with Physics/Renewable Energy from a recognized Institute, with minimum 60% marks and necessary computer skills,
  - ii) Minimum of 5 years' experience in handling Renewable Energy Projects.

- c) The maximum age of Consultant should not be more than 65 years at any point of time of his/her tenure as Consultant.
- d) The period of engagement of services of each Consultant would be as full time basis during which he would not be permitted to take up any other assignment. Initially, the MNREDA will hire Consultants for one year which can be extended for another year depending on the requirement of the service, performance and further suitability of the Consultant for the assigned task. The maximum period up to which the services of each Consultant may be extended, is up to March, 2017.
- e) During the period of engagement of services of each Consultant, his/her consolidated fee would be a maximum of Rs.50,000/- (Rupees fifty thousand) only on pro rata basis from the date of joining. He/she will not be entitled to DA/CCA/HRS, residential telephones, residential accommodation, personal staff, Medical reimbursement, local conveyance allowance. TA/DA .
- f) Each Consultant will be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, he/she will be not draw any remuneration in case of absence beyond 8 days in a year (calculated on a pro-rata basis).
- g) The Ministry or MNREDA would be free to terminate the services of Consultants at any point of time during engagement without any prior notice.
